The global labour market may be facing one of its most formidable challenges yet, with many sectors struggling to recruit. Some news outlets attribute this to a weak economy having an impact on labour markets and thus recruitment. Alarming, the number of individuals out of work has surged by over half a million than before the pandemic began. How does this affect the dental recruitment market?

A significant contributing factor to this predicament is the scarcity of dentists in the labour market, creating 'dental deserts' in more rural areas, discussed in this issue. In response, the current government have announced Golden Hellos in the form of

£20,000 to encourage dentists to tackle the workload in these areas. But is this enough? And how are we all responsible for accelerating the labour market into a peak?
